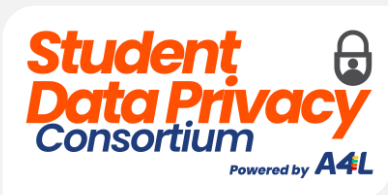


The Access for Learning (A4L) Community develops proven solutions in data interoperability, data privacy, and data security in PK12 education across the globe.
